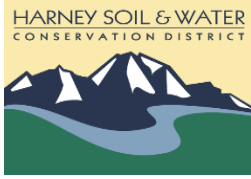

HC17 JUNIPER REMOVAL

The HC17 juniper removal project is located approximately 75 miles from Burns, Oregon, in SE Harney County. It consists mainly of phase II juniper on mild to moderate, sometimes rocky, slopes.

The project will include 6 cutting units totaling 598.91 acres.

Unit 1 (MC)- 49.12 acres of medium to heavier infestation phase 2. Medium diameter trees. This unit will be cut and machine piled.

Unit 2 (MC)- 247.43 acres of medium to heavier infestation phase 2. Medium diameter trees. This unit will be cut and machine piled.

Unit 1 (OLV)- 31.59 acres of phase 2 juniper, areas of medium infestation. This area has big rocks and is somewhat steep. The unit will be a mix of hand and machine cut and pile.

Unit 2 (OLV)- 178.8 acres of phase 2 juniper, areas of medium infestation. This area has big rocks and is somewhat steep. The unit will be a mix of hand and machine cut and pile.

Unit 3 (OLV)- 55.77 acres of phase 2 juniper, areas of medium density trees. This area is rocky with steep hillsides and is a hand cut and pile unit.

Unit 4 (OLV)- 36.20 acres of phase 2 juniper, areas of medium infestation. The unit is rocky and will need to be hand cut and piled.

Both MC and OLV fields require cut, pile, treatment of **standing dead juniper trees** and **downed juniper trees and large juniper woody debris** where practical and as directed by Harney SWCD.

A mandatory bid tour is scheduled for **Thursday, July 16th, 2026**. Expect at least a 5-hour bid tour, meeting at the **Harney SWCD** office at 8:00am. An off-road vehicle is recommended.

Bids will be due on **July 23rd, at 12:00 noon**. The allotted budget for this juniper cut project is \$228,000.

Start date will be **July 24th, 2026**, with project completion expected by **December 1st, 2028**, due to funding allocation and reporting constraints.

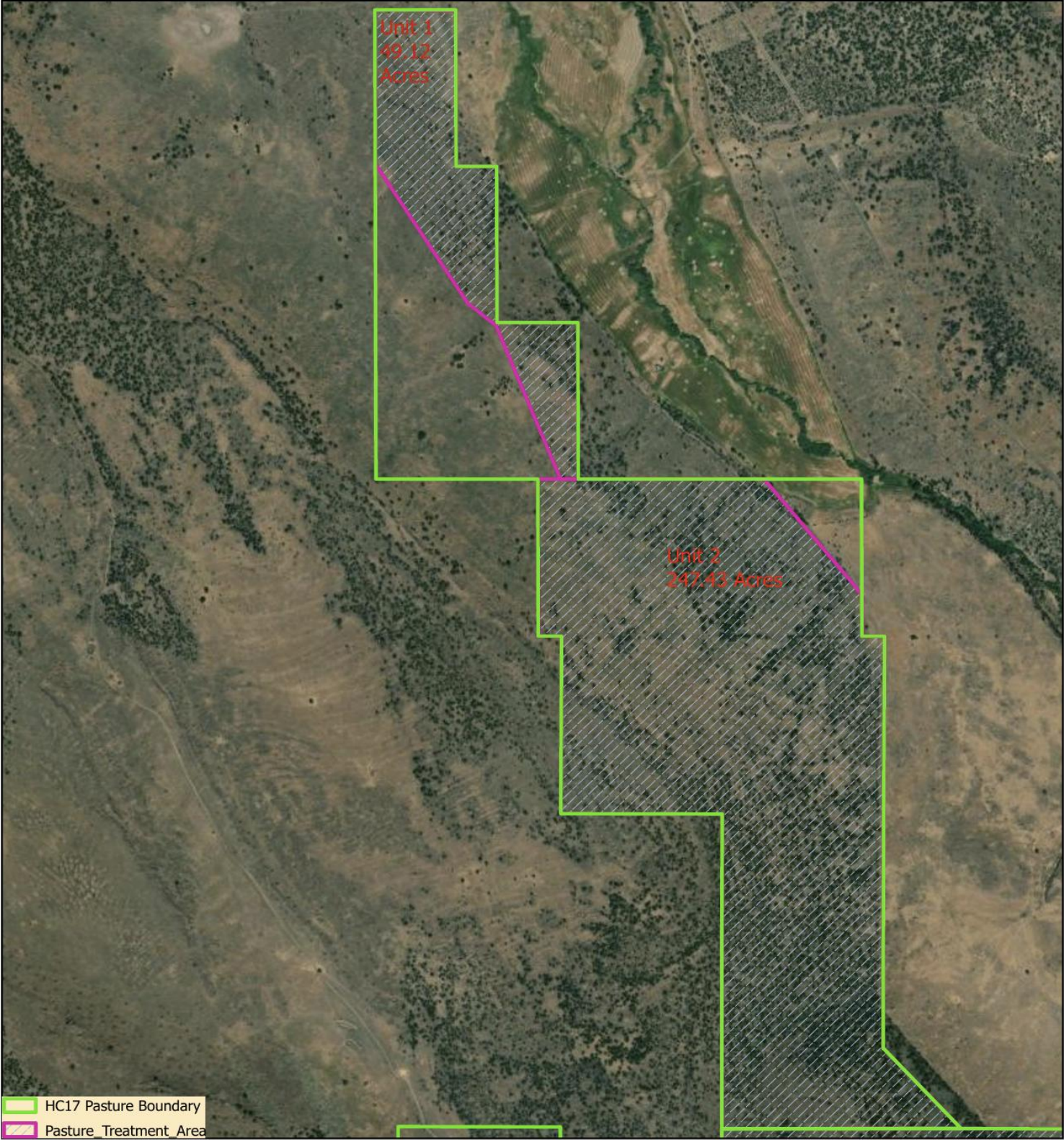

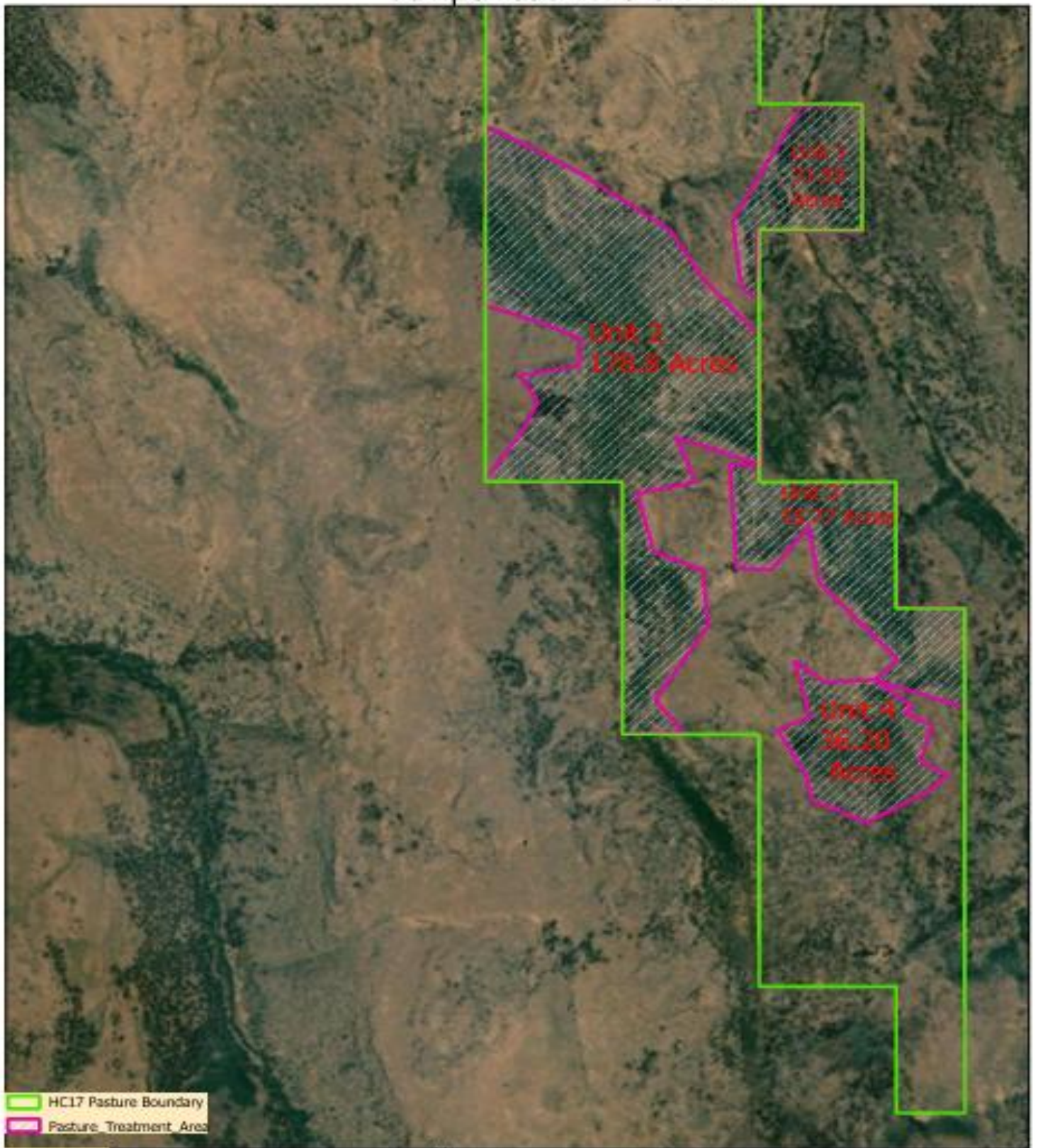
MC Field: Units 1 & 2 Juniper FIP 3.0 Bi 2
